WHAT'S NEW?

IMPORTANT CHANGES ANNOUNCED BY SARS FOR FILING SEASON 2024:

- Beneficial Ownership Reporting: Introduction of requirements to disclose details of beneficial owners on ITR12 forms, enhancing transparency in tax filings.
- Pro-Rata Deductions: Adjustments to retirement fund contribution deductions for periods less than 12 months.
- Tax-Free Investments: Modified limits for shorter assessment periods.
- Solar Energy Tax Credit: 25% deduction on new solar PV panels used from 1 March 2023 to 29 February 2024
- Renewable Energy Tax Incentive: Businesses can deduct 125% of certain machinery costs for renewable energy production until 1 March 2026.
- Urban Development Zone Deductions: Extension of deductions for buildings put to use after 31 March 2025.

- Individual taxpayers (non-provisional):
- 15 July 2024 to 21 October 2024.
- Auto-assessment notices: 1 to 14 July 2024.
- Provisional taxpayers: 15 July 2024 to
 20 January 2025
- 20 January 2025.
- Trusts: 16 September 2024 to 20 January 2025.
